MINUTES OF THE MEETING OF THE COMMITTEE COMPRISING OF HON'BLE MR. JUSTICE V.N. SINHA, HON'BLE JUSTICE SMT. SHEEMA ALI KHAN AND HON'BLE MR. JUSTICE MUNGESHWAR SAHOO HELD ON 11.11.2011 (FRIDAY) AT 4.30 P.M. IN THE CHAMBERS OF HON'BLE MR. JUSTICE V.N.SINHA TO CONSIDER THE PROGRESS MADE IN CONNECTION WITH THE DECISION TAKEN BY THE COMMITTEE ON 13.07.2011, AS APPROVED BY THE STANDING COMMITTEE UNDER MINUTES DATED 2.8.2011 AS ALSO TO CONSIDER THE PROPOSED ACTION TO BE TAKEN BY THE HIGH COURT IN THE LIGHT OF THE OBSERVATIONS OF THE DIVISION BENCH CONTAINED IN ORDERS DATED 26TH SEPTEMBER, 2011 PASSED IN CR.W.J.C. NO. 625 OF 2011.

1. Let a report be called from each of the District & Sessions Judge about compliance of the instruction contained in the resolution of the Standing Committee dated 2nd August, 2011 regarding notification of senior most Magistrate as Presiding Officer of Juvenile Justice Board with instruction to the Presiding Magistrate to first complete the work of the Juvenile Justice Board on all the seven days of the week and thereafter to discharge other work assigned to him as regular Magistrate in the light of direction contained in Memo No. 13216-46 dated 11th August, 2011, copy whereof was forwarded to all the District & Sessions Judges of Bihar in continuation of earlier letter of the Court bearing no. 8443-71 dated 4.11.2004 and 8643-71 dated 11.4.2004.
2. Let a report be sought from the Law Secretary about the formulation of the rules under Section 68 of the Juvenile Justice (Care and Protection of Children) Act, 2000 read with Rule 91 of the Juvenile Justice (Care and Protection of Children) Rules, 2007 for which request was made by the Registrar General under Memo No. 13252-53 dated 11.8.2011.

3. Let a report be called for from the Presiding Magistrate of each of the Juvenile Justice Board about the pendency and the stage of the case pending before the Board. The report should indicate the number and year of the case giving reasons for delay against each of the case. The report should be called through fax reaching this Court within two weeks of the receipt of the communication in this regard.
4. In order to ascertain the progress made in connection with Resolution No. 3 and 4 of our minutes dated 3.7.2011 as also to consider the proposed action in the light of the order dated 26.09.2011 passed in Cr.W.J.C.No. 625 of 2011 it is necessary to call a meeting of the departmental heads of Social Welfare, Building, Revenue, Health Department of the Government, for which the Committee is proposing a meeting on 14.11.2011 at 4.30 P.M. Telephonic information be given to all concerned.
